## Year 9 Cumulus Outdoors Camping Trip, Swanage, BH19 2PX Friday 1<sup>st</sup> July to Monday 4<sup>th</sup> July 2022

The Piggott School is planning a Year 9 residential trip next summer to the Cumulus Outdoors Tented Village, near Swanage in Dorset. This trip encourages and promotes independence, self-esteem, confidence, and teamwork.

The group will travel by coach to and from their destination. Accommodation will be in tents; these are provided by Cumulus. All meals and snacks are included. The weekend will include a variety of activities, including a trip to the Dorset Water Park and Mud Run plus Beach Olympics. There will also be a selection of on-site activities such as Bushcraft, Archery and team building games. All off-site and on-site activities are led by qualified Cumulus Outdoors instructors, accompanied by Piggott staff. The Cumulus Outdoors trip will take place from **Friday 1<sup>st</sup> July to Monday 4<sup>th</sup> July 2022** inclusive; these are the dates shown as Activity Days on the School's calendar.

The cost of the trip is expected to be approximately **£300-330**. The exact figure will be finalised once student numbers have been confirmed. Should the numbers fall below the minimum threshold then there will either be an increase in the cost or if there is insufficient interest, the trip will not take place. Pupils in receipt of free school meals are eligible for funding on this trip. If your son/daughter is in receipt of pupil premium, the school may be able to support with the funding of the trip should you require financial assistance. If you would like your child to participate in this trip, please **complete the Consent Form** and **pay the £75 deposit** by **Tuesday 5<sup>th</sup> October**. The £75 deposit should be paid online via SCOpay. If you have any difficulties with accessing your SCOpay account, the Finance team can be contacted on [finance@piggottschool.org](mailto:finance@piggottschool.org) or by phoning the school.

The trip is expected to be extremely popular, so please be reminded that if you wish to secure a guaranteed place for your child, you must ensure that the deposit is paid, and the consent form submitted, by **Tuesday 5<sup>th</sup> October**. Any requests for places received after this date will be subject to availability and therefore cannot be guaranteed.

An information meeting for all parents and students will be held prior to the departure of the trip.

## Year 9 Cumulus Outdoors Trip – Further Information

Friday 1<sup>st</sup> July to Monday 4<sup>th</sup> July 2022

The cost of the trip will be approximately **£300-330 per student**. We will confirm the exact cost once we have final numbers. This cost of the trip covers:

- Return travel by coach
- Tented accommodation and all meals and snacks
- Full programme of activities
- Staff costs and administration fees
- Travel, Personal Accident and Medical insurance (this covers Covid related cancellations)

Once the final cost has been confirmed, you may pay the balance of the trip as soon as convenient however, should you wish to pay in instalments, please adhere to the following minimum payment deadlines:

Whilst away, all students are expected to behave to a very high standard, as laid out in the School Behaviour contract. We reserve the right to withdraw a student from the trip if we believe their behaviour would have a detrimental effect on the rest of the party, or that their own safety and welfare may be at risk. We would endeavour to find a replacement student and then all monies may be refunded, subject to an administration charge. If, however, we were unable to find a replacement, the initial payment and any incurred cancellation charges, would not be refunded.

Should your child withdraw prior to the trip, or you are unable to continue payments, you would lose the initial payment, and any payments already made would be used to cover cancellation charges, the balance being refunded.
